General Motors warrants to the original retail purchaser for the time and/or mileage indicated below, that it will repair or replace, at its option, this GM Performance Exhaust System or Tip if it fails due to defect in material or workmanship.

Dealer-installed after GM New Vehicle Limited Warranty	12 months or 12,000 miles whichever occurs first (parts and labor)	On date of installation by GM dealer
Other than GM dealer-installed	12 Months (parts only)	On date of original sale by GM dealer

If a GM Performance Exhaust System or Tip is no longer available, General Motors reserves the right to replace with a product of equal value, or refund the purchase price.

OBTAINING REPAIRS:

- **GM Dealer Installation** - Return the vehicle to the GM dealer which installed the GM Performance Exhaust System or Tip, or any GM dealer.
- **Other than GM Dealer Installed** - Return the GM Performance Exhaust System or Tip to the selling GM dealer, or any GM dealer.

DOCUMENTATION REQUIREMENTS:

- Provide the GM dealer this limited warranty statement and the purchaser's copy of the original repair order or sales slip. The lifetime warranty only applies to the original purchaser. All other warranties may be transferred to subsequent owners by providing the above referenced documents.

THIS WARRANTY DOES NOT COVER:

- Damage caused by negligence, alteration, accident or use for which the part(s) was not designed or approved by GM.
- Parts used in commercial fleet application, racing or other competition.
- Towing, rental vehicles, inconvenience, loss of time, use of the vehicle or other loss.
- Exhaust System Part(s) installed on vehicles registered and normally operated outside the United States and Canada.

OTHER TERMS:

Any implied warranty of merchantability or fitness for a particular purpose applicable to these parts is limited in duration to that of this written warranty. The remedy provided above is the exclusive remedy under this written warranty or any implied warranty.

Some states do not allow any limitation on the duration of an implied warranty or the exclusion or limitation of incidental or consequential damages; the above limitations or exclusions may not therefore apply to you. This warranty provides specific legal rights; you may also have other rights depending on the state or province in which you reside.
